### **Examples of City of Conyers Boards and Authorities:**

**Conyers Convention and Visitors Bureau** – Promotes tourism, trade, and conventions for the City of Conyers.

**Conyers Downtown Development Authority** – Promotes the retention and expansion of new businesses; recruits new businesses, new development and redevelopment; promotes balanced growth and enhances the character of Olde Town; implements beautification and quality of life projects; and explores incentives and development options with the tax allocation district.

**Historic Preservation Commission** – Promotes and protects the historic attributes and interests of businesses and homes in the city's historic district.

**Conyers Housing Authority** – Governing board of the Conyers Housing Authority.

**Conyers-Rockdale Library Board** - Establishes policies governing library programs, including rules and regulations governing the use of the library.

**Conyers-Rockdale Planning Commission** - The Conyers-Rockdale Planning Commission conducts public hearings, requests and receives studies and reports from staff, and reviews and makes recommendations for approval. The Conyers-Rockdale Planning Commission is made up of appointments from the Rockdale County Board of Commissioners and the City of Conyers Mayor and Council.

**Board of Zoning, Appeals and Adjustments** – Reviews applications related to variances for building setbacks, reviews appeals of variances of building code and hears appeals related to zoning regulations and building code.
