- Bands or individual performers must supply an example (CD) of their music or performance with the application.
- All participants must sign the release statement in order for the application to be accepted.
- The Olde Town Fall Festival reserves the right to reject any organization whose presentation, goals, or objectives may be offensive and not in the best interest of the community.
- **The APPLICATION DEADLINE IS August 24, 2020.**
- An entertainer failing to meet all of the requirements and regulations may be asked to leave the festival area.
